NO construction should begin until you receive a letter back stating whether your request was approved or denied.

ONLY the Board of Directors acting as the Architectural Control Committee can approve or deny your request.

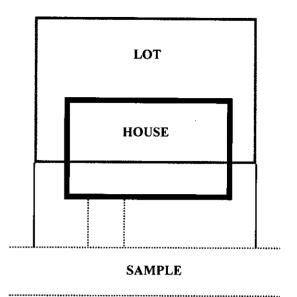
